- 8. Original bank statement up to date covering last 3 months of transactions + Original bank solvency (of the cost bearer).
- 9. Covering letter / Request letter / Forwarding letter.
- 10. Introduction Letter (Yourself).
- 11. Trade license attested by a notary public (For businessmen).
- 12. Income tax return / TIN attested by a notary public (Business person & employee).
- 13. NOC + Visiting card + Official ID (Only for employees)
- 14. Membership + Memorandum + Incorporation + Export + Import certificate attested by a notary public (Only for businessmen).
- 15. Applicant aged below 18 traveling with one parent needs to provide a permission letter from another parent.
- 16. BMDC certificate or Bar Council certificate attested by a notary public (Occupation wise).
- 17. Retirement letter for the official personnel who are retired attested by a notary public.

Checklist for Turkey Business VISA

- 1. A valid passport with 6 months validity on the date of application and it should have at least 2 empty pages
- 2. Passport bio-data page photocopies (3 copies).
- 3. 3 copies of biometric photos with white backgrounds that were taken within the last 6 months covering the full face including ears and all hair, clearly and completely visible without shadow, in size 2×2



- 8. Hotel reservation.
- 9. Original bank statement up to date covering last 3 months of transactions + Original bank solvency (of the cost bearer).
- 10. Letter of introduction from the company (If the visit will be made on behalf of a company).
- 11. Letter of invitation from an individual or institution in Türkiye (Properly signed and directly sent by e-mail or fax to the Embassy).
- 12. Trade license attested by a notary public, Import-Export License, LC (If exist).
- 13. Income tax return + TIN attested by a notary public (Business & Employee).
- 14. NOC + Visiting card + Official ID (Only for employees).
- 15. Membership + Memorandum + Incorporation + Export + Import certificate attested by a notary public (Only for businessmen).
- 16. BMDC certificate/Bar Council certificate/ Retirement Papers for retired Govt. Officials attested by a notary public (Occupation wise).
- 17. Other supporting documents if available (Employment agreement, Old Türkiye Visa, Tapu, Inviter residence permit, or Visa Copy.
- 18. Introduction letter (Yourself)
